



Pool Rental Agreement

Members reserving the pool for an event must submit a completed Rental Request Form to our Pool Manager as well as a guest list 2 weeks prior to the event in order for Castle Rock to appropriately plan staffing for your event.

All pool rules attached are in place for your safety. Any behavior that compromises the safety of the members or interferes with the lifeguards is prohibited. Lifeguards are in place for your safety and are instructed to follow and enforce these rules strictly. Please respect our pool and its members, and most of all enjoy your experience at THE ROCK! ****ALL COVID-19 PRECAUTIONS AND REGULATIONS MUST BE FOLLOWED AS WELL. Castle Rock Pool members are not charged a fee for entry; the host is responsible for \$5 guest fee per each individual that is not a non-member of Castle Rock Pool. Any party-goer that will not be swimming (parents, grandparents, guardians, etc.) will not need to pay a guest fee. Renter must be present at event at all times. No guests must be left unattended. Guest list must be attached with Rental Agreement.

If the pool is closed due to weather – we will reschedule or refund. Please add rain date to secure a reschedule. If it is raining, but not thundering and you are able to swim, the rental will be upheld.

Renters are required to clean up the facility to restore to its original fashion. Facility staff will assist in cleaning and trash duties, but all decorations, tables or chairs that were moved must be put back in their proper location.

Additional fees will apply, should the following occur during a rental time frame:

- Damage to the Club, pool, or surrounding area while an event is in progress.
- Renter occupancy or number of guest exceeds the Rental Agreement

Rentals and Rates

Private screened-in porch rental

- \$100.00 per 4 hours
- includes table and chairs
- \$5 guest fee required for swimmers

After hours full facility rental (any rental that begins or continues after 8 pm-10 pm, or before opening)

- Rate depends on number of attendees, but does not require guest fee
 - 1-50 = \$300
 - 51-99 = \$350
 - 100+ = \$425
- \$75.00 non-refundable deposit required (this is a portion of your full rental)
- lifeguards are provided by facility

Pool Rules

ALL PERSONS USING THE POOL FACILITIES DO SO AT THEIR OWN RISK

Smoking and vaping is prohibited inside the pool gates. Please remain 20 yards from entrances.

Please shower before entering the pool.

An adult must accompany all children under the age of 12 - NO EXCEPTIONS!

Children 12 years and over must pass a swimming test to use the facility without adult supervision.

Running, rough play, profanity, etc. is strictly prohibited.

The baby pool is restricted to children 5 and under with adult supervision only.

The last 10 minutes of every hour is rest period; children under 5 permitted to swim with an adult.

Toys and Floats are allowed at the discretion of the lifeguards.

No hanging on pool ropes.

No free swimming in the deep end/diving board area. In the deep end, children and adults must have the ability to swim on their own without floatation devices (no arm floaties, etc.)

Diving Board area must be clear before use. Must jump straight out. No jumping backwards or double jumping.

No animals allowed in the pool area.

ABSOLUTELY NO GLASS allowed in the facility at any time.

Any behavior that compromises the safety of the members or interferes with the lifeguards is strictly prohibited.

MANAGEMENT RESERVES THE RIGHT TO REFUSE ADMITTANCE TO, OR EJECT FROM THE PREMISES, ANY PERSONS FAILING TO COMPLY WITH ANY RULES OR HEALTH REGULATIONS.
